#### Behavioral Health

## New Guidelines

Each office will be implementing new guidelines to protect the health of staff and visitors. Individual offices may have specific guidelines, but in general visitors will be asked to follow these guidelines:

- Please wear a mask when you enter the building.
- Social distance as best as possible.
- Limit the number of visitors at an appointment. Staff will be limiting the number of

visitors allowed in the building at a time.

- Do not come to the office if you are ill. Reschedule your appointment if you or a close family member is feeling ill.
- Visitors will take a health screening questionnaire before appointment.
- Visitors will wait for their appointment in the car and receive a text to enter the building at their appointment time.
- Bathrooms will not be open to visitors.
